This information below is an excerpt from the Enrolment Management Plan and explains the Enrolment Criteria in more detail.

Enrolment Criteria

Students who reside outside the school's local catchment boundary who apply for enrolment at the school will be put on a waiting list in order of receipt of application. Where there is spare capacity, students will be enrolled from the waiting list based on the following criteria and order of priority:

- Siblings of students already enrolled
- > Children and young people who are subject to child protection orders that grant guardianship or custody to the Chief Executive Officer of the Department of Child Safety.
- > Students whose parents are in the process of purchasing a block of land, within the enrolment boundary, with the intention of building and residing therein; or who are building a house within the enrolment boundary for the purpose of residing at that address
- > Students whose parent or legal guardian is employed by the school or are paid P&C Association employees.
- Siblings of students who have left the school and reside outside of the local catchment boundary.
- Any remaining students residing outside the catchment area.

Students who reside outside the catchment area and who officially leave the school will be considered for re-admission in accordance with enrolment criteria as stated above.

Should the enrolment capacity of the school change because of the introduction of new programs and initiatives and/or the development of further stages of the school, this will be formally notified through the registration and gazettal of an amended plan.
